EMW FY2021-22 Budgeted Funds were approved June 16, 2021 for expansion projects which limited CNG Equipment purchases.

IV. Product Description and Specifications

Item 1. TGT-7203-8CNG50W/5CNG6 – Twin High Hose Stand Alone CNG Dispenser with Alpha Numeric display, keypad, RS232 port, The Micro Motion ® CNG50 sensor and AGA 1-93 approved Parker Parflex CNG fill hose as well as ASME pressure relief valve.

V. Procurement Criteria:

EMW Gas Association intends to purchase a TGT-7203-8CNG50 W/5CNG6 Twin High Hose Stand Alone CNG dispenser and associated hoses and nozzles and electronics from Tulsa Gas Technologies, Inc. This equipment is precisely fitted and designed for the exact specifications needed to assist in the delivery of CNG fuel from the existing CNG equipment EMW will be supplying the public for CNG vehicles.

Items included in the proposal are priced at 20% of the manufacturer's 2022 appraised value of new equipment and include a one (1) year warranty on the parts and 90 days on labor from startup completion.

VI. Sole Source Justification:

The August, 2018 Updated EMW Gas Association CNG Feasibility Study produced by Bohannan Huston, Inc. indicates the public benefits of the project and reports that it is in the best interest of the EMW to provide retail-priced Compressed Natural Gas to the public along the Interstate 40 Corridor in Moriarty, New Mexico.

In addition, because Natural Gas is the cleanest, least environmentally harmful fossil fuel available, the addition of this service further supports EMW Gas Association's commitment to the environment.

It is the professional judgement of the Chief Procurement Officer that the precise pre-fitted specifications of this equipment, the excellent brand-new condition in which it is to be purchased, the discounted price of the equipment and its associated documentation justifies the Sole Source Determination of this procurement.

VII. Unique properties of Service/Items of Personal Property Sought:

- ✓ The opportunity to provide additional infrastructure fills a large public service gap between CNG pumping stations along the 1-40 corridor
- ✓ The unique character and opportunity of this procurement is that the brandnew equipment from the TGT manufacturer will be discounted at 20% offlist price saving over ten thousand (\$10,000) dollars, as well as permitting direct connection and communication to the existing structure and equipment and having unlimited phone and data support through the manufacturer with purchase.

- Similar Professional Services/Items of Personal Property Disqualifying Factors: Because the equipment needed is specific to equipment already onsite it will include all necessary electronics to function and communicate properly with the existing equipment and Fuel Master card reader. The price will include warranties, 1-day startup, calibration, and training, it is believed that no alternatives exist.
- IX. **Entity Due Diligence for Determination Basis:** This determination is being published for 30 days on the www.emwgas.com website and inserted once in a major newspaper of general circulation. This notice will further allow challenges and permit the Chief Procurement Office to evaluate the availability of alternatives which will fulfill project and budgetary needs of EMW Gas Association. In the event another vendor challenges the determination, the procurement will be stopped and a formal, sealed-bid solicitation for new

equipment will be issued at the direction of the Board of Directors.
